Total Est. Time: 45 min. Total Est. Distance: 28.24 mi.

- 1: Start out going NORTHWEST on OLYMPIC DR SE toward HARBORVIEW DR SE. 0.2 miles
- 2: OLYMPIC DR SE becomes WA-305/WA-305 NE. 13.5 miles
- 3: Merge onto WA-3 S toward BREMERTON. 7.1 miles
- 4: Take the WA-303 S exit toward E BREMERTON. 0.1 miles
- 5: Take the ramp toward FAIRGROUNDS/EAST BREMERTON. 0.3 miles
- 6: Turn SLIGHT RIGHT onto NW WAAGA WAY / WA-303 S. Continue to follow WA-303 S. 6.0 miles
- 7: Turn LEFT onto NE RIDDELL RD. 0.7 miles
- 8: NE RIDDELL RD becomes PERRY AVE NE. 0.1 miles
- 9: End at Kitsap Unitarian Universalist Fellowship

- 1: Start out going NORTH on WASHINGTON AVE/ WA-304 N toward TERMINAL WAY. Continue to follow WASHINGTON AVE. 0.4 miles
- 2: Turn RIGHT onto MANETTE BRIDGE. 0.3 miles
- 3: Turn LEFT onto WHEATON WAY. 0.1 miles
- 4: Turn SLIGHT RIGHT onto WINFIELD AVE. 0.3 miles
- 5: WINFIELD AVE becomes E HIGHLANDS ST. 0.1 miles
- 6: Turn LEFT onto PERRY AVE NE. 1.8 miles
- 7: End at Kitsap Unitarian Universalist Fellowship

- 1: Start out going WEST on WA-16 W. 21.7 miles
- 2: WA-16 W becomes WA-3 N. 1.8 miles
- 3: Merge onto WA-304 N toward BREMERTON / FERRY. 1.7 miles
- 4: Turn SLIGHT RIGHT onto BURWELL ST / WA-304. 0.9 miles
- 5: Turn LEFT onto WARREN AVE / WA-303. Continue to follow WA-303. 2.1 miles
- 6: Turn RIGHT onto SYLVAN WAY / WA-306. 0.7 miles
- 7: Turn LEFT onto PERRY AVE NE. 0.6 miles
- 8: End at Kitsap Unitarian Universalist Fellowship
